As per rule 36(9)(a)(iv) of the University leave rules Mr. Imam Hasan, Assistant Professor, Department of Anatomy and Histology who was granted study leave on full average pay for 3 (three) years from 11.12.2022 to 05.04.2025 under this office order No. Sec-2/A-04/2020/1138/Estt. dated: 08.12.2022 is granted extension of his study leave on full average pay for a further period of 8(eight) months 25 (twenty five) days from 06.04.2025 to 31.12.2025 for completion of his Ph.D. degree from the University of Insubria, Italy as mentioned below:

- 1. As per rule 36(14)(a) of the University leave rules the period of study leave granted to Mr. Imam Hasan for the period from 06.04.2025 to 31.12.2025 is treated as on deputation and counted as qualifying service for the purpose of pension, annual increments, house rent allowance, medical allowance, festival allowance and any other financial benefits.
- 2. He shall be bound to return to this University immediatly after completion of degree and shall also serve this University for a minimum period of 4(four) years 8(eight) months 4 (four) days.
- 3. If he applies for leave/interruption while staying abroad while on study leave and not joining the University service, the date of leave/interruption shall be fixed in his favor on the previous day of the last sanctioned study leave i.e. his last working day in the University;
- 4. In case of breach of the conditions of the bond executed, the amount of salary allowance received/to be received during the period of educational leave shall be refundable from his with 15% simple interest. The period of employment during which there is no salary allowance in accordance with Government Decisions/Rules, study leave shall not be counted as period of employment. That is, the period during which the appointing authority refunds/withdraws the salary allowances shall not be treated as pensionable service;
- 5. If, after joining the University as a self-employed person after joining the university as per the terms of the executed bond, he applies for voluntary retirement/interruption without completing the period for which he is committed to serve, in that case, the period he will serve shall be adjusted proportionately to his. The salary will be withdrawn from his and the pension case will be settled as per Government/University rules after determining his actual length of service accordingly;
- 6. Government service rules, pension rules, circulars, office orders, instructions and decisions issued by the Government of the People's Republic of Bangladesh from time to time adopted by the University shall be applicable;
- 7. If he does not return to the University in due course, the University authorities may recover his one-time pension and the entire amount of his status in the Provident Fund to compensate his outstanding bond. He will have no objection to it and his heirs in his absence will have no objection and objection will not be legally admissible;
